Hence his nomination has been rejected.

**Executive Member:** Nomination of Sh. Narender Kumar at Sr. No. 19 of electoral College, is inoperative because he has not been seconded by any member who is properly entered in the valid Electoral College for the post of Executive member in view of para 7 (2) of Model Election guide lines published on dated 25-9-2025 of the Notification. Hence his nomination has been rejected.
