Smt. Surekha, HSFA requested the chair to preside the meeting. The members present in the house unanimously agreed to it. Sh. V. K Beniwal, Convenor, HSFA took the chair with the thanks to the house and welcomed all the delegates at the meeting.

Smt. Surekha requested Sh. V. K. Beniwal to start the proceedings.

Having confirmed that the house is in order by the participating District Associations / Institutions /Boards/ Units and registered members of HSFA under society act, he asked Smt. Surekha to start the proceedings as per the Agenda of the Annual General Body Meeting, already circulated to all concerned and a copy of the same was also provided to all the members.

Smt. Surekha initiated the proceedings and took-up the Agenda Items for the discussion / approval.

Agenda Item No 1:

To Consider & Confirm the Minutes of last Annual General Body Meeting of Haryana State Fencing Association.

Smt. Surekha, Secretary General, Haryana State Fencing Association, placed before the house, the minutes of the AGM held on 15th November 2024 at Eklavya Sports School, Sisay, Hisar for confirmation.

Sh. Devender, Secretary General, District Fencing Association Rohtak, proposed to confirm the minutes. Sh. Amit Kumar, Treasurer, District Fencing Association Jind, seconded it and the members present unanimously approved the minutes.

Agenda Item No 2:

Election of Executive Committee consisting of Office Bearers and Members as per the Constitution of HSFA for the term 2025-28.

Smt. Surekha informed the house regarding the Election of Haryana state Fencing Association for the term of 2025 - 28. She said that vide District Registrar of Societies Sonipat letter dated 15.7.2025 (Enclosed), ad-hoc committee of three members was constituted to conduct the elections of Governing Body within three months from the issue of above letter. Members of the said committee: 1) Sh. Vipin Kumar Beniwal (Convenor), 2) Smt. Surekha (Female member), 3) Sh. Deepak Saini (Ex. International Player) decided in the meeting held on 20.08.2025 at the registered office of HSFA. After deliberations the said committee arrived at a decision that for venue, date and timeline etc. for the Elections will be; **THE ATRIUM (Meeting Room), Hotel Amrik Sukhdev, G.T. Road, Murthal, Sonipat, Haryana-131001 and on 7th October, 2025 at 10:00 AM.** Notice for the AGM/HSFA Elections – 2025 and appointment of returning officer was delivered to all the HSFA members registered under society act.

Hon'ble Sh. Jaswinder, Registrar SUOH Rai, Sonipat has been appointed as the Returning Officer vide HSFA letter no. HSFA/AGM/RO-1/SNP-2025/1-Spl, dated 22.08.2025 after obtaining his consent.

A list of registered members under society act along with a list of affiliated District Units was provided to the Returning officer.

Notice served to all the Affiliated District units vide letter no. **HSFA/AGM-2025/SNP/2-Spl, dated 22.09.2025** with a request to send the names of two representatives for Elections and AGM through mail by 25.09.2025

After receiving the names of representatives, the "Preliminary List of Electoral College" was prepared by HSFA on 25-09-2025 and circulated to the member units. **The same has been displayed on HSFA Website "www.hsfa.ind.in"**

Election Guidelines and Schedule were issued by the Returning Officer on 25-09-2025 to commence the Formal Election Process and the same has been displayed on HSFA Website "www.hsfa.ind.in"

Name of the representatives from District Panchkula, Karnal, Fatehabad and Nuh were not received within given timeline or after. Final List of the Electoral College prepared and handed over to the Returning Officer on 25-09-2025. Above List of the Electoral College was signed by Returning Officer & thereafter circulated to all the units and displayed on HSFA Website "www.hsfa.ind.in".

Returning Officer Sh. Jaswinder, registrar SUOH, Rai informed the house that Nominations were received as per the stipulated date, time and schedule in the Model Election Guidelines for HSFA Elections - 2025. Against the 7 posts as per the provisions of the Constitution of HSFA, for which the present election is being held, 10 Nos. of nominations have been received. After the scrutiny, 7 Nos. of Nominations were found valid. One nomination for the post of executive member has been withdrawal. After the due date for the Withdrawal, 6 Nos. of Nominations were left for the Elections, as there were only equal or less nominations received for each post, there is no need to conduct the elections. All members nominated are unanimously elected on their posts.

There being no other points for discussion by any member, the Secretary General took the permission of the President to thank all the members in the house and to conclude the meeting.


